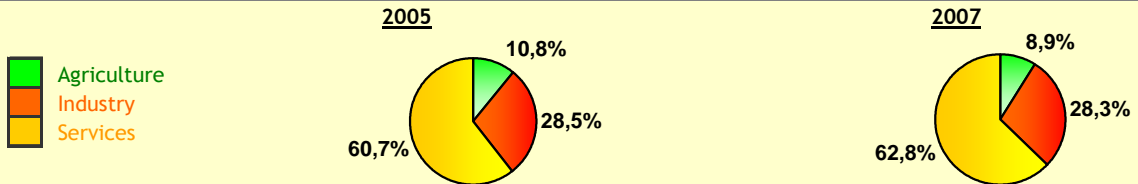

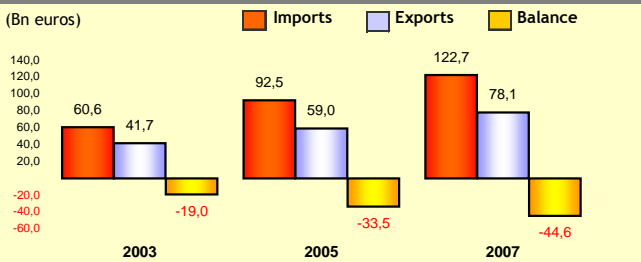

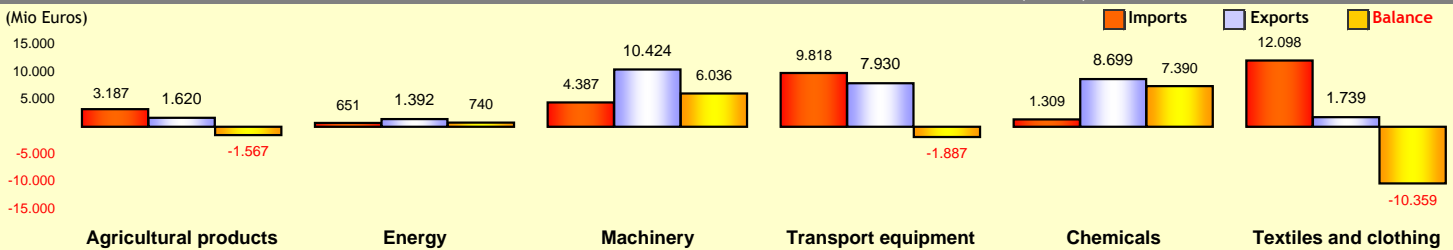
EU27 MERCHANDISE TRADE WITH TURKEY

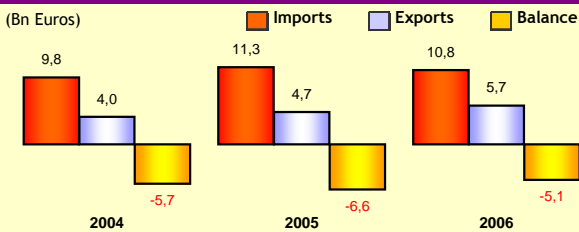

EU27 MERCHANDISE TRADE WITH TURKEY BY PRODUCT (2007)



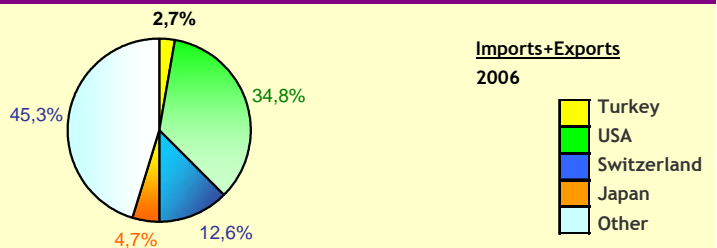

EU27 TRADE IN SERVICES WITH TURKEY

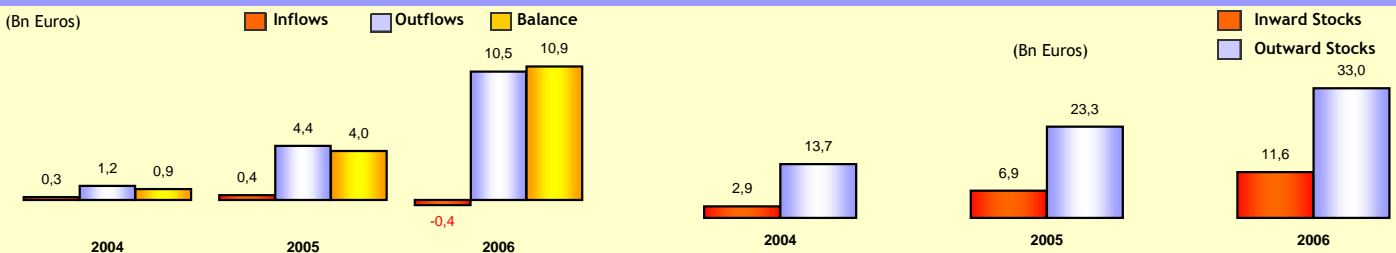

TURKEY SHARE OF EU25 TRADE IN SERVICES

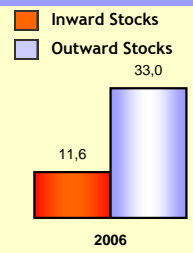


EU27 FOREIGN DIRECT INVESTMENT WITH TURKEY

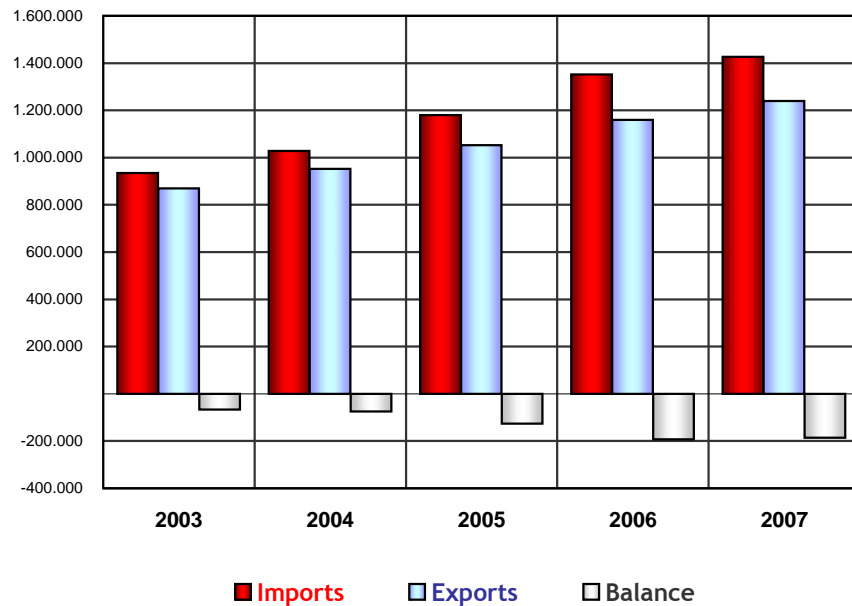

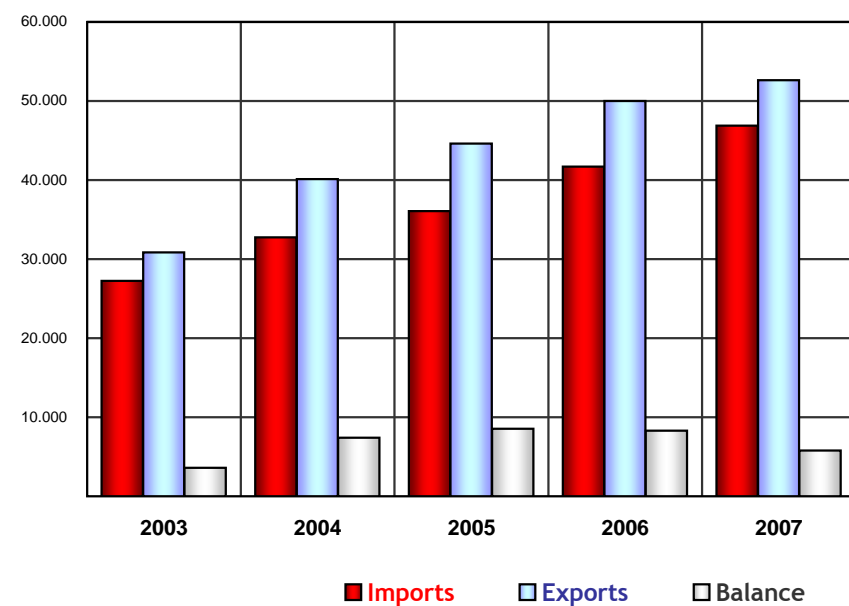

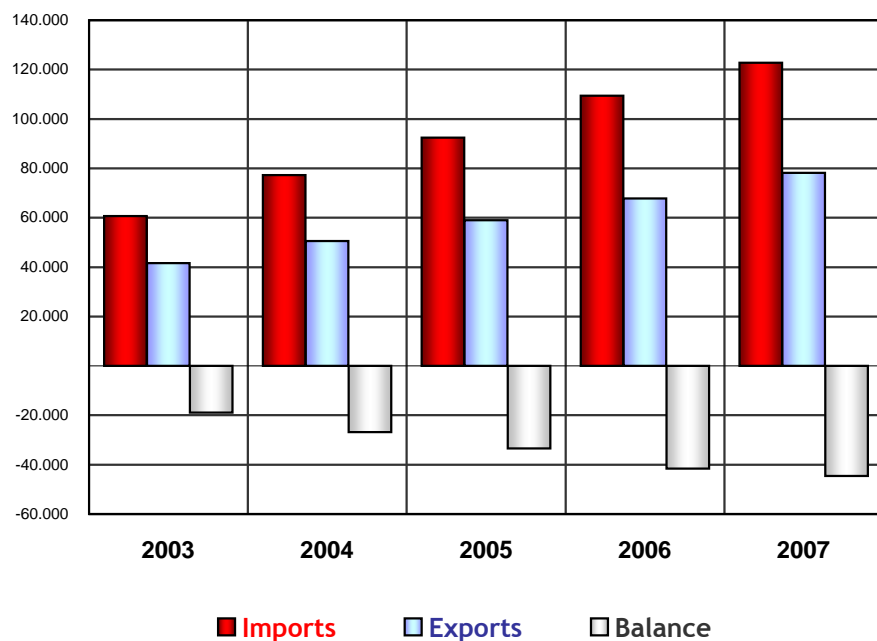

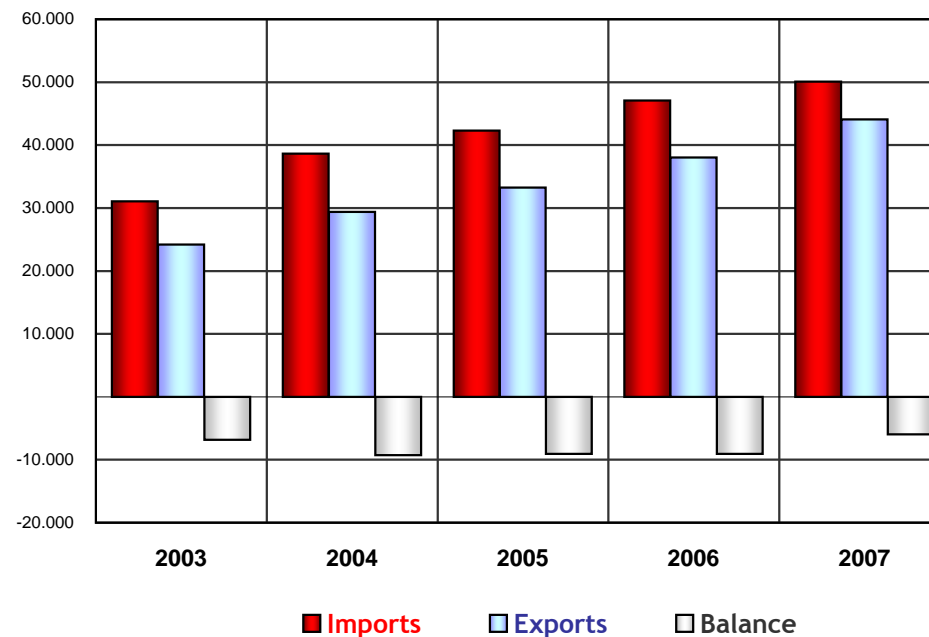

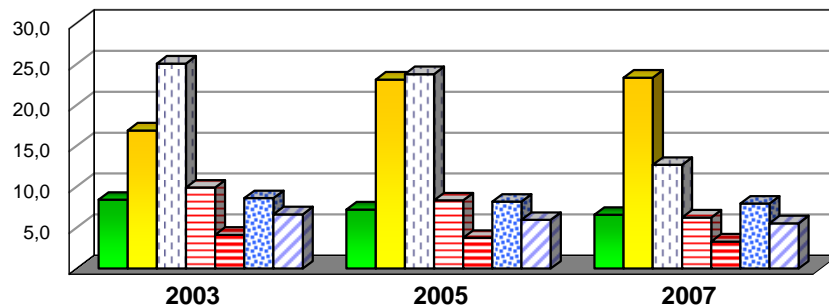

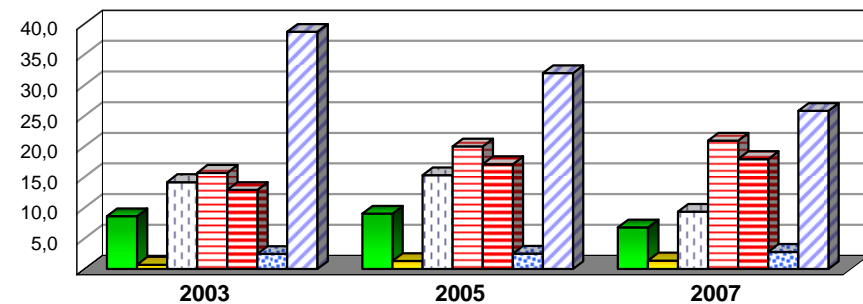

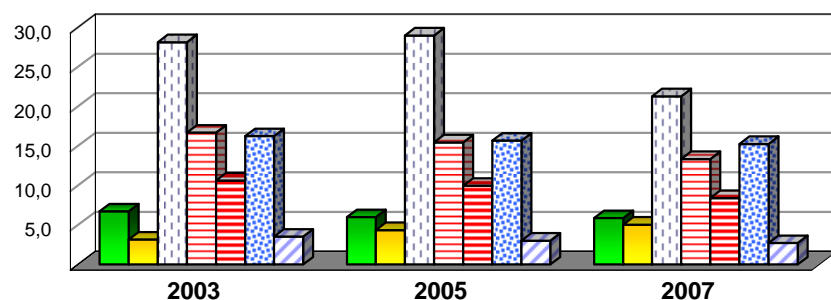

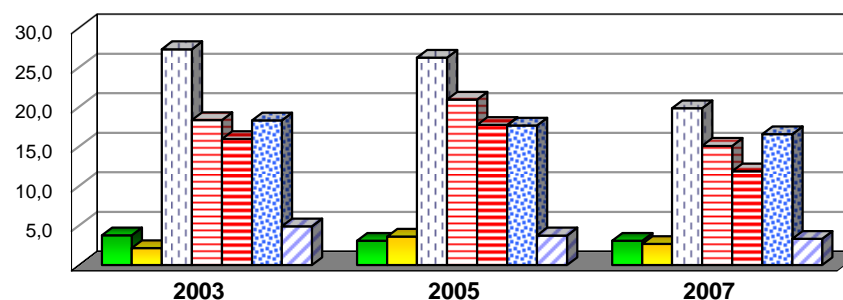

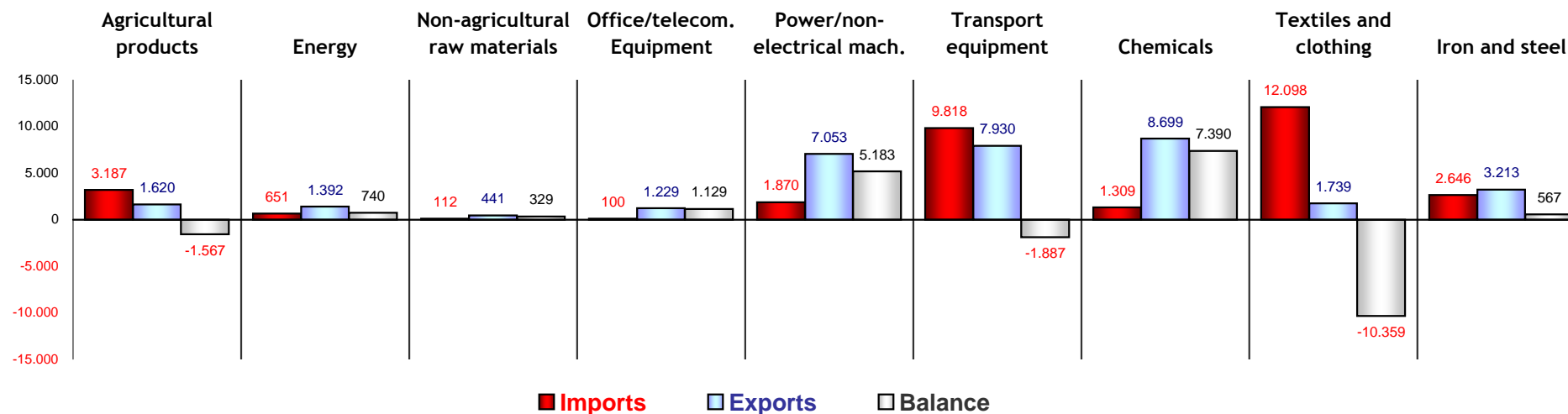
